



## Expanded Access to Health Care Products

Great news for those who have a Health Savings Account (HSA), Flexible Spending Account (FSA) or Health Reimbursement Arrangement (HRA)—the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into effect on March 27, 2020, giving you more purchasing power than ever with 20K+ products added to the list of eligible items you can buy using your pre-tax account.

- **Over-the-counter (OTC) drugs and medicines** like cold remedies and fever reducers no longer require a prescription for reimbursement and are now more easily accessible... So stock up and stay healthy.
- **Menstrual care products** like pads, tampons, liners, cups and sponges are now eligible—good news for women everywhere!

**These items are staying on the list of eligible items permanently.** Long-awaited, these additions aren't coming off the list after the COVID-19 pandemic is over, they are here to stay, giving you access to more of the most commonly used products we use in our households every day.

### How it Works

- **Use Your Payment Card:** Once retailers have updated their online and instore payment systems and inventories (anticipated by May 2020) you can use your card to pay for these newly eligible items, but remember to always save your receipts in case your purchase needs to be verified later
- **Submitting Online and Mobile App Claims:** You can also submit claims for reimbursement through your online account or using the [myCYC mobile app](#). Additionally, you can re-submit previously denied claims for items purchased after January 1, 2020 that are now eligible as part of the CARES Act.
- **Shop the CYC Marketplace:** This convenient shopping option allows you to use your CYC payment card to have purchases directly deducted from your pre-tax account, takes the guesswork out of product eligibility, offers discounts and incentives, and gives you quick and easy access to the products you need from the comfort of home.
